

## How Studiosity may help fulfil TEQSA standards

Implementation of Studiosity to your students may help meet new minimum standards, effective 1 January 2017.



### 1. Student Participation and Attainment

New TEQSA Higher Education Standard requirement	Section of Framework	How Studiosity might be applied to help meet the standard
Provid[e] access to informed advice and timely referral to academic or other support.	1.3.2a	Supports students with on-demand, after-hours and weekend academic literacy intervention and refers students to the Higher Education Providers' other support channels when required.
...provide students with timely feedback that assists in their achievement of learning outcomes.	1.3.3	The Writing Feedback service delivers 24/7 academic writing and referencing feedback that is personalised, timely and driven by an iterative drafting process; feedback is designed to help students think about and improve upon their own work.

Processes that identify students at risk of unsatisfactory progress and provide specific support are implemented across all courses of study.	1.3.4	Delivers regular activity reports and transcripts, which can assist lecturers to identify at-risk students or cohorts. Provides students with tailored, personalised, academic intervention specific to their immediate need.
Students have equivalent opportunities for successful transition into and progression through their course of study, irrespective of their educational background, entry pathway, mode or place of study.	1.3.6	Promotes equity and accessibility across all student cohorts. As an online, anonymous service, students seeking help and feedback are able to access Studiosity regardless of their background, location or style of study.
The specified learning outcomes for each course of study encompass discipline-related and generic outcomes, including skills in independent and critical thinking suitable for life-long learning.	1.4.2d	Studiosity's methodology is centered on the encouragement of critical thinking and independent learning. Knowledge of and access to the service normalises help-seeking for students in an anonymous, low-pressure environment. Studiosity supports generic and foundation skills and learning outcomes, allowing lecturers to focus on their specialties and course content.

Institutional policies, practices and approaches to teaching and learning are designed to accommodate student diversity, including the under-representation and/or disadvantage experienced by identified groups, and create equivalent opportunities for academic success regardless of students' backgrounds.	2.2.1	Promotes equity and accessibility across all student cohorts. As an online, anonymous service, students seeking help and feedback are able to access Studiosity regardless of their background, location or style of study.
Participation, progress, and completion by identified student subgroups are monitored and the findings are used to inform admission policies and improvement of teaching, learning and support strategies for those subgroups.	2.2.3	Delivers regular reporting with participation data and student feedback. Providers can use Studiosity data and feedback to inform policies and future teaching, learning and student support strategies.

Access to learning resources does not present unexpected barriers, costs or technology requirements for students, including for students with special needs and those who study off campus	3.3.3	Delivers the service directly through the learning management system of your institution. Students simply log in to your LMS, click a link within their course page and are authenticated directly to the Studiosity learning environment where the process is completely intuitive. No additional software, account or login is required. If a student has access to the LMS, they will be able to access a Studiosity support session.
Students have access to learning support services that are consistent with the requirements of their course of study, their mode of study and the learning needs of student cohorts, including arrangements for supporting and maintaining contact with students who are off campus.	3.3.4	Provides access to experts who uphold Australian tertiary education standards, to support your students. Problem-specific and generic academic literacy concepts are reinforced. This is delivered online, after hours and on weekends making it location agnostic, equitable and ethical 'just-in-time' support.
